- -Where A Transfer Of Interest Is To Be Made To A Third Party, The Purchaser Shall Bear The Cost Of Procuring New Survey Plans And Title Deeds And Any Other Document Required To Transfer The Interest.

The Applicable Cost Shall Be Determined By The Vendor At The Time Of Notification Of Intention To Transfer.

## 9. WHAT HAPPENS IF I CANNOT CONTINUE WITH THE PAYMENT? CAN I GET A REFUND?
